#### I. SELF-DECLARATION FORMS FOR INSURANCE POLICIES

It has come to our attention that some insurance companies are asking insurance policy applicants to fill in self-declaration forms that require clinical information such as blood pressure readings, hypertension complications, chest X-ray, ECG results, and so on.

Please be advised that should your patients request you to provide the clinical information that these self-declaration forms require, or to fill up the forms on their behalf, you can charge an appropriate fee for rendering these services.

#### 2. HAVE YOU BEEN A MEMBER FOR 30 YEARS OR MORE?

At the SMA AGM on 1 April 2007, the proposed amendment to the SMA Constitution Article III Section (ii)(c) to grant Life Membership to Ordinary Members who have been in continuous membership for 30 years without further payment of subscriptions was successfully passed. In accordance with Article XII, Section 5, which states: "No amendments shall take effect until such amendments have been approved by the Registrar of Societies." We shall be writing to ROS in due course.

We note that several members have been with SMA for 30 years or more and would qualify for Life Membership under the new Article III Section (ii)(c).

However, in view of the above constitutional requirement, we will only be able to grant you Life Membership <u>after we receive official approval</u> <u>from ROS</u>. This means that your Life Membership will only take effect in <u>2008</u>.

In the meantime, we would be grateful if members with outstanding subscriptions send their payment to us. We appreciate that you have been a SMA Member for 30 years or more, and we look forward to your continued membership and support.

All members who qualify for Life Membership will receive a notification letter in the later part of the year.

# Survey on the Practice 2007 of Aesthetic Medicine

An Aesthetic Medicine Workgroup has been set up by MOH to look into issues pertaining to aesthetic medicine. The workgroup, led by Prof Goh Chee Leok of the National Skin Centre, has wide representation from the private and public sectors, and include dermatologists, plastic surgeons, general practitioners and representatives from the College of Family Physicians and Singapore Medical Association. The workgroup has decided to conduct a survey on the practice of aesthetic medicine which will include randomly selected doctors in the private sector.

Aesthetic Medicine is a new area of practice that deserves the profession's attention. For a start, we need to know to what extent the profession and individual doctors are involved in the practice of aesthetic medicine. We also need to know the prevailing standards of training doctors have received in this area.

To this end, the 48<sup>th</sup> SMA Council feels that this survey is timely and necessary. If you are selected for the survey, we hope that you can give it your fullest support by responding. This will ensure representative findings from the survey. The data collected will be strictly confidential and analysis of the data will only be made on an aggregate and de-identified basis.
