SMA ANNUAL MEMBERSHIP SUBSCRIPTION FEES 2009: AUTO DEDUCTION THROUGH THE UOB-SMA VISA PLATINUM CARD

The SMA Council would like to thank members who supported the payment of SMA Annual Membership Subscription Fees by auto deduction through their UOB-SMA Visa Platinum Card in February 2008. We are pleased to announce that SMA subscriptions will be collected by autodeduction in January/February 2009 again. The deductions will be as follows:

Rates are in Singapore Dollars and <u>include 7% GST</u> (except for Overseas Membership). Rates have been adopted at SMA Annual General Meeting 2007 and approved by Registry of Society (ROS), Singapore.

The process of auto deduction is as follows:

- 1) For members who had stayed opted in to the scheme since 2007, your SMA membership subscription for Year 2009 will be automatically deducted through your UOB-SMA Visa Platinum Card in January or February 2009.
- 2) You will receive this deducted bill in your January/February/March 2009 UOB-SMA credit card statement.
- 3) If there is any query regarding SMA membership subscription fee deduction, please clarify with SMA at Tel: 6223 1264 (ext 19 or 18) or Email: accounts@sma.org.sg within three (3) months of receipt of your UOB credit card statement.
- 4) SMA will mail you a receipt after the successful auto deduction. You can submit the receipt for tax deduction in your income tax submission as usual.
