Medical expert witnesses

The evidence in a medical expert report and testimony offered by a medical expert witness during examination are often critical components in arriving at an equitable and fair decision in any dispute.

An expert witness possesses in depth knowledge of a subject that enables him or her to give opinions and draw conclusions relevant to the case, so as to impartially and objectively assist the court or tribunal in its work. The expert witness is expected to articulate the standard of care in medical negligence, the standard of professional conduct in disciplinary tribunals, and present opinions that are supported by strong arguments and evidence.

To serve the course of justice effectively, a medical expert should be familiar with the principles of medical negligence, litigation, and the judicial system. With the rising expectations of the public and patients on the performance and behaviour of doctors, it is timely that competent and skilled medical expert witnesses are available for the benefit of patients, the public and the profession.

About the course

The purpose of the training session is to highlight the duties and responsibilities of doctors who wish to act as medical experts in medical negligence claims.

Over the course of two days, topics like the legal principles underpinning clinical negligence claims, the litigation process in Singapore, the role of the expert, and what makes a good report, will be covered.

You will also have the chance to find out more about appearing in court and courtroom skills, as well as hear from experienced experts about the problems and challenges of being an expert.
