CERTIFICATION OF DEATH

Medical certification is a privilege solely accorded to registered medical practitioners by society and the law. The certification of death carries with it a serious duty and significant responsibilities in its execution. The appropriate knowledge, skills and attitudes are necessary to fulfil this responsibility. Failure or neglect of this responsibility would lead to serious legal, ethical and professional repercussions.

When called to do such certification of death, the practitioner must have reviewed the past medical history and the recent medical illness. The doctor needs to understand the difference between the cause of death and the mechanism or mode of death. The doctor must discern and make appropriate clinical judgement as to the relevant contributory cause of death. Doctors must be



aware of their responsibilities under the Coroners Act. The Coroners Act 2010 requires all doctors to be able to recognise when deaths need to be reported to the Coroner. Reportable deaths are classified as mandatory or discretionary.

The doctor certifying death has also to understand the stress and grief situation that the bereaved family is undergoing. He has to exhibit the appropriate professional demeanour and conduct. Medical professionals must acquire the skills and attitudes in expressing appropriate empathy to all concerned while carrying his duty effectively.



MAIN SPEAKER

This workshop will cover topics of the duty of care in death certification, factors that lead to the breach of this duty, the professional conduct expected, common errors in certification, and hands on practice in filling death certificates based on case scenarios.

This workshop will be led and facilitated by Dr Lai Siang Hui from the Department of Pathology, Singapore General Hospital (SGH) and a board member of the SMA Centre for Medical Ethics and Professionalism.

Prior to his appointment as Consultant at the Department of Pathology, SGH, Dr Lai practised as a forensic pathologist at the Health Sciences Authority of Singapore, where he was Head (Research) and later Head (Training & Education). He is currently also Residency Director of the SingHealth Pathology Residency Programme. He has Associate Professor appointments with Duke-NUS Graduate Medical School, as well as the School of Biological Sciences at Nanyang Technological University. He is also Clinical

Senior Lecturer with the Department of Pathology, Yong Loo Lin School of Medicine.

Besides usual work commitments, Dr Lai finds time for other professional and social activities. He serves as Vice President of the Medico-Legal Society of Singapore.

Dr Lai is married with two children and spends his limited spare time with his family. Outside professional work, he occasionally helps out at the grassroots level as well. Last but not least, he is also lay minister at his church where he serves as leader and is privileged to share from the pulpit occasionally.
